Amy Case King is from Dallas Texas, who resides in Yucatan Mexico, began her medical cannabis activism and therapeutic application of the plant 15 years ago to help her uncle, a Vietnam Veteran, who suffered from severe alcoholism, PTSD, COPD and a myriad of other physical ailments.

She is the founder of Delta 9 Mexico, a Mexican company dedicated to the advancement of science for industrial and medical uses of Cannabis sativa.

Amy is passionate about educating others on the medicinal uses of cannabis. She has extensively researched the historical use of cannabis, current scientific data of therapeutic applications and regularly attends educational cannabinoid conferences around the world so that she can best serve those who seek her guidance in the application of cannabis. Amy is an international drug policy activist. She has spent the past four years focused on the international scheduling of cannabis. She is a member of FAAAT (For Alternative Approaches to Addiction) a think tank for international drug policy. She has attended and spoken on behalf of US patients at the World Health Organization, Expert Committee of Drug Dependence, hearing for the cannabidiol and cannabis critical review. She has worked intimately at the United Nations, Commission of Narcotic Drugs (CND), in regards to cannabis drug policy changes where the WHO recommendations will be voted on.

She is a contributing author to CANNABIS & SUSTAINABLE DEVELOPMENT: Paving the way for the next decade in Cannabis and hemp policies. The report explains how the reform of hemp and cannabis policies can help to achieve the 2030 United Nations agenda for Sustainable Development. She is a registered Holistic Cannabis Practitioner since 2018. Holistic Cannabis Academy programs are approved by the National Association of Nutrition Professionals as part of its Advanced Specialty program.

For over 20yrs Jenny suffered the horrible effects of Fibromyalgia, bodywide chronic pain and nerve damage from a car accident until she discovered Cannabis oil. After going off all pharmaceutical pain medication her health just kept improving and soon she was helping many others too. On 4th January 2017 South Australian police raided her home which resulted in subsequent charges of Manufacture, Possession and Supply of Cannabis oil and the same charges for Cannabis Resin. This carried a sentence of 18yrs jail. Jenny was forced to plead guilty and in Nov 2019 was given a No Conviction and a 2yr bond. She was helping approximately 120 people free of charge at the time of her arrest with amazing results, including many children. Medical conditions she was treating included Epilepsy, a large range of Cancers including Brain Cancers and Leukemia, Auto Immune diseases, pain, anxiety, depression and many other conditions. A leading Brain Surgeon sent patients to her which inspired him to start official trials using Cannabis for brain tumors. Now Jenny works as an activist, trying to change the laws in Australia. She is trying to make sure a safe, affordable product is available for all that need it. She also teaches people how easy it is for them to make their own Cannabis oil at home and take their health back into their own hands. Jenny's expertise lies in her experience prescribing the right type of cannabis oil and delivery method for each medical condition.

Harish Kumar is originally from Pahang and moved to Kuala Lumpur when he was in primary school. Harish has always been interested in forming solutions for problems in the world and has participated in many programs, competitions, debates and others alike to contribute as much as possible. While studying at the National Defense University of Malaysia (NDUM) in 2015, he decided to follow his passion to study the depth of the human psychology which led him to discover the cannabis plant. Still new in the cannabis scene, he started a national survey based on the research questions provided by Prof. Mitch Earleywine, University of Albany that was modified to fit Malaysian contexts. The study gathered 962 respondents in two months and was noticed by Intan Mustika. Intan contacted Harish and they have worked together ever since. In 2018, Intan and Harish decided to form MASA in order to continue advocating for human rights and to become the leading center for psychedelic plant and alternative treatments research, development and education.
